

RESOLUTION NO. 2011- 49
CREATION OF OFF-HIGHWAY VEHICLE ADVISORY BOARD

WHEREAS, *Idaho Code* § 67-7126 and IDAPA 26.01.31.251 give the Kootenai County Commissioners the authority to create an Off-Highway Vehicle Advisory Board; and,

WHEREAS, upon creation of the advisory board, the appointed board members will serve in an advisory capacity, without salaries or wages, for purposes of (1) establishing an Off-Highway Vehicle Law Enforcement Program which is recognized by the State of Idaho, Department of Parks & Recreation; (2) overseeing off-highway related law enforcement activities undertaken by the Off-Highway Vehicle Law Enforcement Program; (3) expending funds deposited into an off-highway vehicle law enforcement fund established by the State of Idaho and allocated for off-highway related law enforcement activities; and, (4) implementing the goals of the Off-Highway Vehicle Law Enforcement Program; and,

WHEREAS, several members of the community have voluntarily been acting as an unofficial advisory committee who have been working on the formation of an Off-Highway Vehicle Law Enforcement Program; and,

WHEREAS, the volunteer members have made recommendations to the Kootenai County Commissioners for the formal establishment of an Off-Highway Vehicle Advisory Board; and,

WHEREAS, the Kootenai County Board of Commissioners have determined that it would be in the best interest of the County, as well as the citizens thereof, to create an Off-Highway Vehicle Advisory Board to oversee the establishment of, and the activities and functions of, the Off-Highway Vehicle Law Enforcement Program.

NOW, THEREFORE, BE IT HEREBY RESOLVED that the Off-Highway Vehicle Advisory Board be created, and that individuals appointed shall serve at the pleasure of the Board of County Commissioners, and shall consist of the following:

Kootenai County Commissioner Dan Green
Kootenai County Sergeant Ryan Higgins
Kootenai County Deputy Jeff Burns
A member of a local motorcycle group
A member of an ATV/UTV group

BE IT FURTHER RESOLVED that the Off-Highway Vehicle Advisory Board shall conduct its business in accordance with the provisions of *Idaho Code* § 67-7126 and IDAPA 26.01.31.251.
