

RESOLUTION NO. 2010-27
Sewer Connection and Monthly User Fees

WHEREAS, *Idaho Code* §21-401 authorizes counties to acquire, lease, and otherwise operate aviation fields together with equipment necessary and incidental to the maintenance and operation of an airport; and,

WHEREAS, Kootenai County owns and operates an aviation field known as the "Coeur d'Alene Airport" on approximately 1,100 acres of land located north of the City of Coeur d'Alene, Kootenai County, State of Idaho; and,

WHEREAS, the continued use and operation of the Coeur d'Alene Airport has necessitated providing for off-site sewage disposal in accordance with the directives of the Panhandle Health District; and,

WHEREAS, Kootenai County has contracted with the Hayden Area Regional Sewer Board for sewage disposal services at their Regional Treatment Facility and has constructed a sewage collection system known as the "airport System"; and,

WHEREAS, Kootenai County has and will continue to incur expenses for the operation, maintenance, and expansion of said utility system at the Coeur d'Alene Airport; and,

WHEREAS, *Idaho Code* provides that counties may fix fees to be charged for the use of the airports and their related facilities; and,

WHEREAS, the Board of Commissioners of Kootenai County has received notification from Hayden Area Regional Sewer Board of proposed fee increases.

NOW, THEREFORE, BE IT RESOLVED, by the Board of Commissioners of Kootenai County that the following described fees be charged for sewer services at the Coeur d'Alene Airport:

- 1) **SEWER SERVICES:**
 - A) Hook-up Fee: The prevailing rate for Equivalent Residential unit as established by the City of Hayden, presently \$8,795.00.
 - B) Monthly Service Fee: \$25.00 per month per Equivalent Residential use as above described.
- 2) Said fees shall be subject to future review and change as deemed appropriate by the Kootenai County Board of Commissioners in order to properly maintain and operate the system.
- 3) The above fees shall become effective immediately upon passage by the Kootenai County Board of Commissioners.

BE IT FURTHER RESOLVED, this Resolution supercedes Resolution No. 2005- 23, enacted by the Kootenai County Board of Commissioners on March 22, 2005.
